1 Snapshot of CDNet activities in 2017-18 financial year

1.1 CDNet Terms of Reference

The Community Development Network of the ACT & Region (known as CDNet) is a support network of community development workers and those interested in community development principles and practices. Our purpose is to:

- 1. Facilitate the sharing of information on current trends, good practice and activities relevant to community development through an email distribution list;
- 2. Provide information on the role of community development to ensure a sound foundation for healthy and sustainable communities; and
- 3. Provide opportunities for discussion and learning through seminars, workshops and conferences.

CDNet receives core annual funding from the ACT government for the following key activities:

- 2 A Steering Committee to oversee and coordinate the activities of the CDNet, supported by the employment of a secretariat position;
- 3 Maintenance of the CDNet website and distribution of emails to the CDNet, supported by the employment of an administrative position to manage the website and moderate the email list, and
- 4 Organising two forums, seminars or workshops per year.

1.3 Forum and workshop descriptions in brief

The Community Development Peer Network - bi-monthly meetings

A collaboration between ACTCOSS and CDNet, this network provides a regular opportunity to meet, network, and share ideas on resources, practice and tools for people working within a community development framework in the ACT.

Storytelling Project - March-June 2018

Two workshops to develop storytelling skills facilitated by TEDX presenters to the CD Peer Network; Engaging four ACU Master of Social Work Student to develop stories of community development

Asset Based Community Development Masterclass by Cormac Russell & Peter Kenyon - 3 May 2018

A collaboration between ACTCOSS, Communities@Work and CDNet to bring leading experts in ABCD (a strengths-based approach) to Canberra. Over 80 people attended.

Celebrating the Hidden Strengths of Community Development: Stories of Collaboration and Impact – 25 June 2018

Over 50 people registered and 15 on the waiting list. 40 people attended.

Comparison with previous years

The amount of 'traffic' on the email list has consistently been about 50 emails a week, which continued this financial year. The table and figure below show monthly averages for the last seven years.

2.3 Budget

The budget for 2017-18 is at **Attachment 1**, and the most recent Profit and Loss Statement (13 June 2018) is at **Attachment 1B**.

An underspend of about \$230 is anticipated after the 25 June forum costs and wages have been paid out.

Full details of expenditure will be provided after ACTCOSS' audit later this year.

2.4 CDNet Steering Committee

CDNet's Steering Committee oversees and coordinates the activities of the CDNet. It has representatives from a wide range of community organisations. It maintains 12--15 active members per year (12 at present – see **Attachment 2** for details). Some have been in the Steering Committee for several years; every year, 2-3 people 'move on' to other positions or organisations, At the start of each financial year, emails are sent to CDNet inviting new people to join the Steering Committee for one year. This usually results in 3-4 EOIs, as it did this year.

The CDNet Steering Committee met six times during the 2017-18 financial period, usually every 8 weeks.

Attendance per meeting has varied from 5 to 10, averaging 7 per meeting with 5 to 7 'active members' sending apologies. This is consistent with previous years' averages.

2.4.2 CDNet Secretariat position

This position has an annual contract for 90 hours per annum @ MEA 6.3 + 25% loading to:

- Organise 5-6 Steering Committee meetings a year (preparing, organising, attending, minutes, etc.) average 5 hours per month (60 hours per annum)
- Support forum organisation (publicity, registrations, evaluation, catering payment, etc.) 15 hours
- Organise the budget & write an annual summary report 15 hours.

2.4.3 CDNet email list administrator position

The email administrator contract is for 2 hours a week @ MEA 6.3 + 25% loading for moderation of CDNet email list and website content management, plus 5 hours per annum for website maintenance.

2.5 The Community Development Peer Network

Beginning in June 2015, CDNet and ACTCOSS' Capability Development team trialled Community Development Peer Network bi-monthly meetings. The aim was to provide a more focused format in which community development workers could regularly meet to nut out issues of importance to them.

The format has proved useful and popular. There are 20 regular attendees, with 2-3 new people attending most meetings. Some are new to the ACT, or to the community sector or have an interest in connecting with the community.

The CD Peer Network aims to promote and support the practices and principles of community development and provides a forum to:

- Learn from the experience of others
- Share information, resources, tools and practices
- Develop connections with like-minded individuals and organisations.

CD Peer Network evaluation in brief:

Based on evaluative discussions at Peer Network meetings and between ACTCOSS and CDNet facilitators:

What works well? A recurring theme was the value of a peer support space. People value being connected and inspired. The interest for 2018 was that support space to continue, as challenges change quarter to quarter. Conversations are free-flowing. There are usually 2-3 new people at every meeting – either new to the ACT or the community sector.

What does not work so well? Getting speakers can be difficult. There is expertise in the group. So, a change will be to balance support and sharing with guest speakers by having every second meeting be a workshop.

2.6 Forums and workshops

Full forum descriptions will be more detailed in the annual summary report due in September.

Evaluations for the two larger forums are in the pipeline at the time of writing.

Attachment 3: CDNet Community Development Storytelling Project

In the first half of 2018, the CDNet Steering Committee focused on a project that aimed to raise awareness of and celebrate community-driven work being done by community workers and community champions. The project comprised three processes:

- Two skills development workshops for community workers and champions, and
- Engaging Australian Catholic University (ACU) Master of Social Work Students to interview CD workers with the aim of developing a resource* that demonstrates and celebrates community development stories.
- Culminating in a larger CDNet forum in June.

 - The second on 10 May built on from the who, what, and why of Workshop 1 to get some insight into the "how" was facilitated by Mel Greenhalgh, a youth and community worker of 21 years. Attachment 4: Asset Based Community Development Masterclass with Cormac Russell & Peter Kenyon

Communities@Work in partnership with the ACT Council of Social Service (ACTCOSS) and the Community Development Network of the ACT & Region (CDNet) presented this workshop to Canberra on 3 May. The facilitators are leading experts in Asset Based Community Development (ABCD), a strengths-based approach that identifies and utilises the assets and skills that already exist within a community. This workshop was designed for community enthusiasts, community builders, and civic leaders who want to discover more about ABCD philosophies and methodologies, and their potential and application.

Workshop Information

Through exciting stories, exercises and lots of humour, this Workshop focused on:

- An in depth understanding of the philosophy, value and practice of ABCD.
- Shifting the development mindset from needs and deficiencies to assets and capacities.
- Highlighting, mapping, connecting and celebrating the diverse range of community assets and harnessing the connected assets for action that enhances places and strengthens caring communities.
- Encouraging community members to make the shift from being consumers, customers and clients of services and programs, to co-producers and citizens.
- Tailoring to your audience communicating and applying ABCD in various sectors, communities and agencies.
- Facilitation and training approaches and skills related to ABCD including gaming, art of hosting and storytelling.
- In depth awareness of ABCD tools, resources and key stories.

About the facilitators

Cormac Russell

Director of ABCD Europe, Managing Director of Nurture Development and a Faculty Member of the ABCD Institute at Northwestern University, Chicago. Cormac has trained communities, agencies, non-governmental organisations and governments in ABCD and other strength-based approaches in Kenya, Southern Sudan, South Africa, the UK, Ireland, the Netherlands, Sweden, Belgium, Singapore, Canada and Australia. Cormac and his team at Nurture Development are currently supporting the development of ABCD demonstration sites across the UK.

Peter Kenyon

Peter is a social capitalist and community enthusiast. Over the last three decades he has worked with over 1600 communities throughout Australia, New Zealand, North America, Africa and the Middle East, seeking to facilitate fresh and creative ways that stimulate community and economic renewal. He is motivated by the desire to create caring, inclusive, connected and enterprising communities and local economies. Peter is convinced that one cannot develop communities from the top down or from the outside in. It requires communities to build from the inside out, and for their members to invest themselves, ideas, assets and resources in the process. Peter created the Bank of I.D.E.A.S. (Initiatives for the Development of Enterprising Action and Strategies) in 1991 to promote such a paradigm shift and assist with the necessary facilitation, ideas and skills. Peter's consulting project work has resulted in assignments in 59 countries and all states of Australia.
